WITNESSETH: That the grantor, for and in consideration of the sum of TEN AND 00/100 DOLLARS (\$10.00) and other valuable considerations, receipt whereof is hereby acknowledged, hereby grants, bargains, sells, aliens, remises, releases, conveys and confirms unto the grantee, all that certain land situate in CHARLOTTE County, Florida, viz:

Lot 558, of Rotonda West, BROADMOOR, according to the plat thereof, as recorded in Plat Book 8, Page 18A through 18L, in the Public Records of CHARLOTTE County, Florida.

Subject to reservations, restrictions, easements and taxes for the year 1990.

GRANTOR(S) COVENANT(S) THAT HE/SHE/THEY DO(ES) NOT RESIDE ON THE ABOVE DESCRIBED LAND OR LAND CONTIGUOUS THERETO.

TO HAVE AND TO HOLD, the same in fee simple forever.

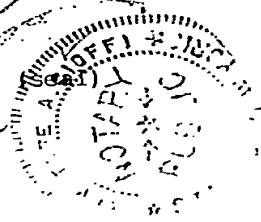
